1 On reading the Verified First Amended Complaint of plaintiffs on file in the above-entitled
2 action, the Memorandum of Points and Authorities, and the accompanying declarations and
3 Request for Judicial Notice, it appears to the satisfaction of the court that this is a proper case for
4 granting an order to show cause for a preliminary injunction and a temporary restraining order, and
5 that, unless the temporary restraining order prayed for be granted, great or irreparable injury will
6 result to plaintiffs and the public before the matter can be heard on notice.

13 construction of the Central Valley Segment of the California High-Speed Rail System, as
14 described in the Central Valley Segment Funding Report (Final – January 1, 2017).

15 IT IS FURTHER ORDERED that the above-named defendants, and each of them, appear
16 in Department 54 of this court, located at 800 Ninth Street, Sacramento, California on
17 _____ (date), at _____ (time), or as soon thereafter as the matter
18 may be heard, then and there to show cause, if any they have, why they and their agents, servants,
19 employees, and representatives, and all persons acting in concert or participating with them, should
20 not be enjoined and restrained during the pendency of this action from engaging in, committing, or
21 performing, directly or indirectly, any and all of the following acts: expending or legally
22 encumbering any public funds derived from Proposition 1A, including funds loaned based on the
23 collateral of public funds derived from Proposition 1A, towards the construction of the Central
